## **MEMBERSHIP CATEGORIES**

### **Founding Members**

are persons, individuals or legal entities, who sign the Adhesion Form, participate in the NODFYR's Assembly of Constitution or are accepted as such by the Board of Directors up to six months after the date of the Public Deed of Constitution.

### **Full Members**

those who, including the founders, are admitted under the terms of the articles of association after the Association has been set up, without the possibility of subscribing to Participation Units.

### **Honorary Members**

those who, under this designation, may be admitted by the General Assembly, on the proposal of the Board of Directors, considering the relevance of their activity and the services rendered to the association or to research in the field of the use of prescribed fire and related matters and of recognised suitability, without the possibility of subscribing to Shares.

### **Temporary Members**

are those who wish to take part in NODFYR activities on a one-off basis for a maximum period of 3 months.

## **ESSENTIAL RIGHTS OF NODFYR PORTUGAL MEMBERS**

### **Full Members**

Without prejudice to the other rights enshrined in the Bylaws and General Internal Regulations, full members have the following rights:

- Attend General Assembly meetings, with the right to vote;
- Electing or being elected as representatives or holding executive positions;
- Intervene in the governance and management, as well as in the services and activities of NODFYR, in accordance with legal and statutory regulations;
- Request and obtain explanations on the administration and management of the NODFYR Board's representatives;
- To present to the General Assembly and the Board of Directors anything that they consider may contribute to the better realisation of NODFYR's social objectives;
- Make use of the common services made available by NODFYR;
- Receive information on NODFYR's activities, as well as its financial situation and examine NODFYR's acts and accounts;
- Form part of the working groups that may be set up;
- Receive a copy of the statutes.

## **GENERAL DUTIES OF NODFYR PORTUGAL MEMBERS**

- Timely payment of membership fees and other financial contributions to the Association;  
To honour NODFYR, namely by publicising their membership;
- Make suggestions and proposals for improvement and contribute to the smooth running of the bodies.
- Accepting and complying with the provisions of these bylaws and other internal rules of the Association;
- Promoting the Association's social and statutory objectives;
- Collaborating in the Association's initiatives;
- The exercise of the associative positions for which they have been elected;
- Complying with the resolutions and resolutions issued by the Board of Directors and the General Assembly.

## **NECESSARY DOCUMENTATION**

- To have signed the Manifesto 'Taking Care of Fire in Europe';
- Present identification document (ID/Passport) to validate the information on the membership form.

## **FIRST FEE**

## **ANNUITY**

NODFYR PORTUGAL members are required to pay a minimum annual membership fee of €20.00 in January each year. This amount does not include personal accident or civil responsibility insurance.

## **SANCTIONS AND AMENDMENTS**

Members who fail to fulfil their obligations may be suspended or excluded following notification. Amendments to the method of payment or requests to disaffiliate must be notified in writing at least 30 days before the start of the new annual fee period. Members with overdue dues lose access to the rights and services provided by the association, such as insurance, access to information and technical support, among other benefits.
